The Regulation (EU) 2016/679 of the European Parliament and of the Council (hereinafter the “Regulation 2016/679”) accomplishes a protection system with reference to the treatment of personal data.

Recalling all definitions offered by art. 4, Regulation 2016/679, with reference to the following information, here below it is briefly described the way in which are going to be used the information provided to Caf Interregionale Dipendenti s.r.l, Via degli Ontani 48, 36100 – Vicenza, fiscal code 02313310241, holder of treatment of your personal data pursuant to the accomplishment of the fiscal assistance task.

Kind of personal data

Object of the treatment are your personal, special categories of personal data and legal data and the special categories of personal data pursuant to Article 9 of Regulation 2016/679 (i.e. personal data revealing racial or ethnic origin, political opinions, religious or philosophical beliefs) and, possibly, those of your relatives or cohabiters, pursuant to the accomplishment of the task object of the assistance proxy and with reference to the obligations provided for by law or by European Community legislation. During the accomplishment of the task, could be necessary to acquire and manage special categories of personal data of yours and, maybe, also of your relatives or cohabiters. In this case, we ask you to give your consent in written way or to give your consent in the same way of the above-mentioned subjects.

Data Controller and responsible

Juridical base for treatment

Your personal data are collected and stored by Caf Interregionale Dipendenti s.r.l. with reference to and for the scope of the procedure of fiscal assistance required.

Compulsory or optional kind of the personal data giving

It is not compulsory to communicate personal and special categories of personal data of yours or of your relatives and cohabiters but in case of deny, we could be unable to accomplish the task You bestowed on us.

Purposes of the treatment

Your personal data are threaten only for the period required to accomplish the fiscal assistance proxy in order to: a) help in tax burdens, b) fulfill duties provided for by law, regulations, European Community legislation and in or to accomplish instructions of the Authority or vigilance bodies, c) carry out tax and fiscal necessities; d) advertise about assistance activities offered by CAF, excluding every communication or transfer to third persons if not compulsory by law. The treatment will be managed in compliance with principles of pertinence and not excess pursuant to art. 5 of Regulation 2016/679. Your data may also be processed to send you information and promotional communications on similar services as well as for carrying out market research or “quality satisfaction” surveys of the services provided in accordance with the provisions of article 130 co 4 of legislative Decree no. 196/2003

It should be noted that the aforementioned personal data will be processed for the aforementioned purposes as well as for normal administrative and accounting purposes, without prejudice to the communications required by legal obligations, for the pursuit of the aforementioned purposes, the data will not be disclosed to other subjects external to Caf and its managers and/or persons in charge of data processing.

Treatment process

With reference to the above-mentioned purposes the data are managed in internet and paper way and are developed with informatic processes. The treatment operations are developed respecting logic and physic safety and reservation of personal data in compliance with art. 4, par.2 of Regulation 2016/679 and following modifications. These data will be memorized and/or developed using informatic processes and will be managed by dedicated persons who can be physical persons or legal subjects and who will be appointed as data treatment manager by Caf Interregionale Dipendenti pursuant to specific agreements.

Personal data recipients

Data conservation period

Your personal data and data of your relatives or cohabitants, will be stored by Caf Interregionale Dipendenti Srl, upon consent, for the period required to perform the assistance and treatment purposes, pursuant to the Legislation ed Regulations and, only in case of fiscal controversies, for an extended period.

Data storage

Your personal data, and in case those of your relatives or cohabiters, are going to be stored by Caf Interregionale Dipendenti srl, on your consent, until the end of the purposes of the entrusted task of fiscal assistance, in compliance with law and regulations and further only in case of tax legal argument.

Access to data bank of the bodies providing services and communication data.

In order to accomplish the entrusted task, we ask You to consent the access to data banks of bodies performing connected services, pursuant to the pertinent agreement (pursuant to art. 116, d.lgs. 196/2003, as modified by d.lgs. 101/2018). Moreover, your personal data, and in case those of your relatives and cohabiters, could be send, upon your consent, to 1) bodies performing services object of the proxy; 2) labour unions; 3) associates bodies; 4) third companies and data storage centres; 5) trade associations.

Withdrawal of the consent

You can withdrawal your consent to personal data treatment, pursuant to art. 7, par. 3, of Regulation 2016/679, sending a mail to Caf Interregionale Dipendenti Srl – Via degli Ontani 48, 36100, Vicenza or sending an e-mail to the following address: assistenza@cafinterregionale.it, attaching copy of your identity document and writing the following text: “I repeal the consent to the use of my personal data”. Your personal data, because of your declaration, will be erased by data base as soon as possible, except cases in which the storage is compulsory in compliance with legal provisions.

Rights of the involved person

In compliance to articles 15 of Regulation 2016/679, you have specific rights. You can verify your personal data, you can obtain the correction of your data, their erasement, limitation, opposition and You can demand the transfer of Your data.
